#### PUBLIC COMMENT:

- Greg Hopkins, 346 Edgewater Consideration to not adopt Senate Bill 137. Requesting governing
  agencies to keep the public informed and is against reducing access to any governmental information,
  please take this into consideration when voting on this topic.
- Mark Leider, 1319 Woodview Ave Letter from Mark Leider was read by the Clerk. Commending the Board for the excellent explanation on the proposed Garbage Referendum and clearly worthy of passage at the April election. Not able to attend the public meeting on March 15<sup>th</sup> but requesting this letter of support entered into the record. Privately contracts for solid waste and infrequently utilizes the Town drop-off site, but a valuable asset. The Town has made significant investments and believes it should remain in operation. Express strong support for Option #3 on the survey to keep the Town's site open one day per week.
