Update from the Town Chairman

The temperatures are warming, the days are getting longer and another spring is just around the corner. That means it's also time for another bi-annual update on what's going on in the Town.

But first I want to take a moment to thank our Town staff and officials and the many volunteers who do the hard work behind the scenes to serve our residents and make this a great place to live. Your dedication and enthusiasm are greatly appreciated.

Here's what's going on.

- Garbage Referendum I want to encourage you to read the article on the garbage referendum, to attend an
 information meeting on March 15, and to vote YES on April 4th. This is a time we must all band together to make sure
 we have a lower-cost garbage collection option for ALL residents.
- New Town Website We are in the process of creating a new Town website. It will be more organized and have
 additional capacity and functionality. For example, you will be able to access our Town board meeting audio files
 directly from the website. If you have any suggestions on how we can improve or use our website please contact the
 Town Office.
- 20-Year Comprehensive Plan Land use planning is critical to maintaining the quality of life of our town residents. We are currently in the process of completing the mandatory 10-year review of our 20-year comprehensive plan. There is still time for you to get involved and make your voice heard! The ad hoc committee assigned to complete this task Bob Werner, Roger Miller, Rich Ternes, Greg Hopkins, Jayne Zabrowski, Mike Lappin will continue to hold public meetings at least into April. Call the Town office or check our website to find out the next scheduled meeting date.
- Municipal Fire Department January 1st marked the commencement of our new municipal fire department. I would
 like to sincerely thank an outstanding group of volunteer firefighters for their service to our Town and for making the
 decision to stay on with the new department. Collectively they dedicate over a thousand of hours of their time each
 year to serve our community. If you have an opportunity to thank a firefighter or first responder for their service,
 please do. I know they would appreciate it.
 - With the new municipal structure we created a separate Fire Advisory Committee to help advise the Town Board on matters related to fire services. The seven-member committee is made up of two Town Board members, two firefighters, and three community members. I would like to recognize and thank *Dave Senkbeil, Matt Fore, Glen Genske, Claudia Bricks, Dan Rostollan and Nancy DesJardins* for serving as initial members of this committee. We are in the process of finding the final community representative.
- County OK/S. Business Drive Road Project You've probably observed that something is going on with County OK/Business Drive south of the roundabout. The County is undergoing a major project to widen the lanes (to 12'), the paved shoulders (to 4') and the gravel shoulders. The project also includes improving the drainage system and leveling

the road grade to provide a safer line of sight for drivers. The project will begin July 10th and be completed in September. Access to homes and business will be available at all times. Non-local traffic will be detoured. Utility poles are currently being relocated in advance of the project. The Town of Wilson must also adjust the depths of our manholes to align with the new road grade. This is estimated to cost the Town in excess of \$100,000.

- Other Planned Road Work in 2017
 - *S.* 13th St. Woodview Ave Ridgewood Lane This is a joint project with the City to address storm water drainage problems. The estimated cost to the Town is \$77,000.
 - Wilson Lima Road Asphalt overlay east of the bridge. Estimated net cost \$35,000.
 - W. Stahl Road Tree and stump removal to improve safety. Estimated cost \$10,000.
 - Additional Road Work Budgeted \$60,000 for center lining, crack filling, seal coating, patching, shouldering, tree removal and bridge inspections.
- Scoop the Poop I get many complaints about residents not picking up after their dogs. Our animal ordinance
 requires that you to pick up after your dogs or be subject to fines of up to \$200. You should never leave your property
 with your dog without a scooper or a bag. Please be considerate of your neighbors.
- Kohler Golf Course The WDNR continues its process of evaluating the proposed Kohler golf course in the Town of Wilson. They published a draft environmental impact statement (EIS) last year in June and held a public meeting in July. Recent discussions with Kohler Company indicate they plan to submit their permitting applications by April and that they've made revisions to their plan to further mitigate wetland impacts. Given this timeline, it is possible that the project could come to the Town of Wilson as early as this fall, at which time the Plan Commission would begin their work to evaluate the conditional use permit (CUP). This would include working with our contracted engineering consultants to evaluate the project's potential impacts, developing conditions to mitigate any major impacts, and making a recommendation on the CUP to the Town Board. The WDNR will hold at least one additional public hearing as part of their final evaluation, and the Town will hold at least one public hearing during its evaluation process. Garbage Referendum on the April 4 Ballot

The Town of Wilson board is asking for your help to ensure our Town residents continue to have a lower-cost option for garbage collection services. The upcoming April 4th ballot will contain a referendum asking your permission for the Town to charge residents a modest fee separate from the general tax levy to recoup some or all of the costs to deliver these services. This same referendum was narrowly defeated in last November's election by a vote of 1155 to 1053.

If residents vote Yes, what options will be evaluated and how will the Town board decide? If the referendum passes there are three plausible options upon which the residents will decide:

- Continue operating the drop-off site as we do today at an estimated cost per household of \$50 per year.

 Admittedly this option would impose an additional fee on those residents already contracting for curbside pickup on their own. However they may still benefit from the drop-off site for disposing of yard waste.
- Provide mandatory curbside pickup and close the drop-off site at an estimated cost per household of \$180 per year. This option would provide mandatory curbside pickup services for less than one half the cost that residents can contract for on their own. We are hearing that residents currently contracting for such services are paying between \$400 and \$500 per year.

 Provide mandatory curbside pickup and keep the drop-off site open once a week for yard waste only at an estimated cost per household of \$200 per year.

The Town Board has to make some tough choices to address our recurring budget deficits. Choices between providing essential services mandated by state statutes – *fire protection, EMS services, road maintenance, property tax administration, election services, etc.* – and other, non-essential services such as garbage collection. The status quo of providing garbage collection services for free at the Town site is simply no longer sustainable and the reason why most if not all townships our size in Wisconsin already charge for these types of services. Without the modest fee, the Town could have little choice but to close the maintenance/drop off site.

Attend the March 15 public information meeting to learn more!

An informational meeting on the garbage referendum will be held on <u>March 15 at 6:30 at the Town Hall.</u> The Town Board will present additional information on the referendum and answer any questions that you have. Also, don't hesitate to contact any of the Town supervisors directly. You can find their contact information on the Town's website at *townwilson.com* or on the back or this newsletter.

The referendum will read as follows.

Under State law, if a municipality imposes a new fee or charge to pay for garbage collection services that had been funded by the municipality's general tax levy in 2013, the municipality must reduce its tax levy limit by an amount equal to the total estimated revenue from the new fee, unless otherwise authorized by referendum. Shall the Town of Wilson be authorized to impose a new fee or charge on an ongoing basis to pay for garbage collection services without reducing its tax levy limit?

Note: An additional informational paragraph will be included on the ballot with the referendum. Also, the direct question you will answer is underlined above. It is not allowed to be underlined on the ballot.

What you should know about the referendum rules and process.

- Why do we need a referendum? A recent change to state statutes restricts local townships from raising new funds through the general levy. Townships with garbage collection fees in place prior to 2014 were grandfathered in. Those wishing to establish garbage collection fees after 2013 are required to hold a referendum.
- Why is the referendum wording so confusing? The specific referendum language is mandated by state law. However, this time we were able to add a second, informational paragraph with permission from the Wisconsin Elections Commission. We hope this helps you to better understand how a YES or NO vote might impact our residents.
- Why can't there be a referendum with a specific solution and cost? State statutes require us to first ask for permission to charge a fee before the Town Board can make a decision on what kind of garbage service to provide and what it will cost.

Why should I support a fee without knowing how much it will be?

- The amount will depend on the type of garbage collection service our residents prefer.
- Be assured that the amount, by state statute, can't be more than what it costs to provide the service.
- With your support of the referendum you will help insure the Town can continue to provide our residents with lower-cost options for garbage collection services.
- If the referendum fails, the future of our maintenance/drop-off site could be in jeopardy and if it were to close it would have the unintended consequences of substantially increasing costs for many residents as they would have to contract for these services on their own.

Once the town residents pass a referendum allowing the Town to charge a fee, the Town board will then make their decision based on what which option the majority of residents prefer.

Parks and Forestry News

Park & Forestry Commission Spring 2017 Activity Report

The Victor Gruber Memorial Fireman's Park/Jung Bell Tower Park renovation is underway! The picnic gazebo has been erected near the bell tower, with painting planned for early spring's warm weather. The parking lot has been re-striped and a handicap space has been added. New tot playground equipment has been selected and will be delivered in April. Planning for toilet facilities, the water station, the fitness trail, and repairing the soccer field are ongoing. The renovation is funded by a Sheboygan County Stewardship Fund Grant and generous donations from private citizens, Wilson Mutual Insurance, and the Town of Wilson.

The P&F Commissioners are planning tree purchases and planting for Schinker Creek Park thanks to a \$5,000 grant from the Wisconsin Regional Plan Commissions and DNR Emerald Ash Borer Mitigation program. Planting will take place this coming spring. The Commission is also working on the establishment of a Citizen Care Committee program of community volunteers to help eliminate invasive plant species in the parks and conservancies and to help us notify the Town Maintenance crew of items that need attention in the parks and conservancies. In early November, the Park & Forestry Commission was notified by a concerned citizen that several Halloween pumpkins and some potted mums had been tossed into the Balzer Woods Wilderness Park along Indian Mound Road and grass clippings have been dumped into the edge of the undeveloped park at the intersection of Riverdale Ave. and South 8th St. Please remember it is a violation of Chapter 30 of the Town Ordinances to dump anything in the Town's parks and violators are subject to a fine. Let's keep our public areas pristine and pleasant for all to enjoy!

Spring Election - April 4, 2017

Elections are held in the Town Hall (the older building in the parking lot) located at 5933 S. Business Drive. ABSENTEE VOTING

• In-person absentee voting in the Clerk's office is approximately 3 weeks prior to an election (or when the ballots are received from County) at the Town Office, 5935 S. Business Drive.

NOTE you cannot vote absentee on the Monday before the election. Please bring your photo ID to Vote.

- Absentee voting in-person in the Clerk's Office is recommended if you are unable to vote the day of election.
 Mailed ballots costs postage is expensive for the municipality and takes time to produce. If you must request a ballot, please allow enough mailing time and please return the ballot promptly. Absentee ballots must be received by 8:00 pm on the day of Election to be counted.
- Requesting an absentee ballot to be mailed: Submit to the Clerk's office a completed Wisconsin
 Application for Absentee Ballot form EL-121 along with your proof of voter ID. Or you can request your
 absentee ballot at www.myvotewi.gov. Any questions, please contact the Town Clerk. Please do not wait
 until the last minute! All voters must also be registered to vote and voter ID is required.

Where is the Drop Box for the Office

If you have used either of the three black boxes at the entrance to the parking lot <u>PLEASE STOP</u>!

These <u>are not</u> drop boxes or for public use and whatever you place inside it will not reach the office!

The Drop Box is still located at the Entrance to the Town Office Building next to the Front Door and the BOX reads "DROP BOX".

From the Treasurer

Dear Residents,

- *Thank you for a successful property tax season. The next Property Tax Installment is due July 31st; please make check payable to Sheboygan County Treasurer or take your payment to Wisconsin Bank & Trust. Yes, the County also uses WB&T. Remember, the County collects your 2nd installment but WB&T collects all installments.
- * The following is a reminder to renew your <u>annual dog(s)'s license</u> before March 31 at the Town office or send me (Treasurer) your payment and a copy of the current rabies certificate. I will then send the tag and new license back to you. You can also e-mail/fax a copy of the current rabies certificate; whichever option is convenient for you. The fee is \$7 for spayed/neutered, \$14 for non-spayed/neutered.

On a side note, <u>9 %</u> on average of the total property tax received <u>stays in the Town of Wilson</u> to provide services. 91% is distributed to the State, County, LTC and your school district.

The Town acts as a <u>tax processing service</u> for the County and School Districts. To put it another way, consider the following; if one pays \$3000 in Property Taxes for 2015, \$270 stays in the Town of Wilson for Town expenses

Update on municipal status for the fire department

The Town of Wilson Black River Fire Department has successfully transitioned to a Municipal Fire Department as of January 1 of this year; with the municipality change, a Fire Advisory Council has also been created. This council will be composed of seven members, two from the town board, three citizens of the town and two members from the fire department.

The new change will assist fire department personnel by alleviating some of the administrative tasks that are consuming firefighter's time. By removing the administrative burdens, the firefighters can focus more efforts on the operational side of the fire department.

Fire Prevention

Make sure that your smoke detector batteries are replaced at least once a year. A great time to do this is on daylight savings, Sunday March 12 this year. A good time to also look at your Carbon Monoxide detector and make sure the unit is not expired. Carbon Monoxide detectors have sensor packs in them and the sensor packs do expire. These are both critical components in the safety of your home.

Town of Wilson Medical First Responders

The Town of Wilson Medical First Responder Unit is in need of volunteers that want to fulfill their civic duty by assisting their neighbors and fellow town residents in their time of need. GENERAL DUTIES: An Emergency Medical Responder (EMR) supports the Town of Wilson, and surrounding areas, by participating in activities including emergency medical response, training, fundraising, maintenance, recruiting, business meetings, and other special activities.

QUALIFICATIONS:

- Minimum of 18 years of age, clean and neat appearance, sound physical condition and no felony convictions.
- Pass a 90-day probationary period.
- Members are not required to live in the Town of Wilson.

TIME REQUIREMENT:

- The initial training for an EMR is 70 hours and is offered at Lakeshore Technical College. The unit pays for the training provided the training is completed successfully.
- Upon successful completion of training, the EMR can take 6-hour shifts. All shifts taken are monetarily compensated once a year.
- Attendance at drills and meetings should be at least 6-8 per year. All meetings and drills are monetarily compensated once a year.
- Refresher training of 30 hours is required once every two years. Refresher training is also paid for by the unit.

BUILDING PERMITS

Any project with a value of \$500 or more a building permit is required. Interior and exterior additions to a residence require a drawing of this area for approval by the building inspector. Re-roofing, siding, windows, exterior doors, fences, decks, sheds and porches all require a building permit. Crash Course On Roads By Supervisor Brian Hoffmann - There are 39.56 miles of town roads. We are responsible for their maintenance. This includes repair and plowing, sometimes repair is just patching. Sometimes it could be a complete rebuild. Last year (2016) we had \$30,000 budgeted to spend on roads. Because of the tight budget we spent little of this. This year we have budgeted \$30,000 plus another roughly \$30,000 coming in from the county. This is money from the recently implemented ½% county wide addition to the state sales tax passed by the Sheboygan County Board. We are happy to receive this.

The cost to overlay one mile of road is \$250,000.00. The cost to rebuild completely one mile of road is one million. Last year our snow plowing cost was \$48,008.65 paid to Wagner Excavating and \$21,003.33 paid to Sheboygan County. Also-there was \$19,746.30 in other contracted services and \$6,647.78 in capital outlay for street improvements. These are separate line items. As you can see it is difficult to have enough money to do an adequate job. We also have five bridges in our town. We just rehabilitated the Wilson/Lima bridge at cost of \$220,628. Our cost was \$110,628. \$77,000 came from a 2015 Sheboygan bridge Aid grant and \$33,000 came from Sheboygan County in 2016.

There are also 6 miles of I-43 and 27.03 miles of county road in our town. We do not have to pay for the maintenance on these roads.

A question we get a lot is how do I change a speed limit on my road? Three steps are involved. 1) The town petitions the county for a speed and safety study. 2) The Sheriff's Department and the County Transportation Department look at it and then make a recommendation to the county board. 3) It is then passed or rejected by the full Sheboygan County Board. It is not always easy to lower a speed limit as the prevalent thinking is that roads are meant to move traffic not slow it down. Lastly, I am asking you to slow it down. I have been directed by the town board to ask the Sheriff's Department to place a radar trailer in the town. They have done so. Also, we have asked for more patrol cars to be in our town on a more regular basis. Your excess speed can usually only result in one of two things. One- an accident or two- a ticket.

I hope you find this article interesting. As you will note the title of this article was "A Crash Course On Roads" let us take the word crash out of play. Also, my thanks to Rick Meyer for help with this article.

MANDATORY RECYCLING

Recycling is mandatory in the State of Wisconsin and statutes have established responsibilities for local governments relating to recycling. The Town of Wilson is required to maintain an effective recycling program for solid waste management, which includes educating its residents about the recycling law. On-going education that reminds residents about local recycling programs is essential for maintaining high recycling rates in our community.

SINGLE STREAM RECYCLING: Single stream recycling simply means that you can now place all of your recyclable items in a BLUE bag. Everything goes into a blue bag: #1 to #7 plastics, aluminum, glass, newspaper, chip board, magazines, catalogs, shredded paper, etc. This is a convenience option, it is not mandatory. There will be one recyclable item that will not be placed in a blue bag and that is CARDBOARD. It's been recommended to separate card board for placement into its own dumpster. The Town shall restrict recyclable items from being placed in our garbage containers. This is consistent with **ORDINANCE 65.02**. RECYCLING IS A WISCONSIN STATE LAW, we will not accept garbage bags that contain recyclables inside. Town residents that have not separated their recyclables will be directed to return home and resort your items if your clear bag contains recyclable items. There is no landfill disposal costs attributed to recyclables so this will help to reduce the cost for all of us in disposal fees. The town of Wilson requires residents to place recyclables into a BLUE BAG and garbage items into a CLEAR BAG, NO EXCEPTIONS. Recycling Center Staff must be able to clearly see through your bag to insure proper disposal of solid waste. This is Wisconsin State Law and simply the right thing to do for our environment.
