

**SANITARY DISTRICT NO. 1 COMMISSIONERS MEETING

**CALL TO ORDER & DECLARATION OF OPEN MEETING:** President Ehmann called the Sanitary District No.1 Commissioners Meeting to order at 5:36 p.m. Posting in accordance with open meeting law was confirmed by affidavit of posting and the meeting was declared an open meeting.

2. **Maintenance related issues as presented by Tom Sanville and/or Otis Kiehl:** Sanville reported on contact from resident, Mike Bergin, regarding possible sink-hole matter, was reviewed by Sanville, Kiehl and Rick Meyer, identified as a pothole and will be corrected with proper fill; discovered manhole with groundwater which has since resolved itself; jetting now completed, video showed a leak at a manhole connection which will be undergoing repair; City of Sheboygan will be borrowing SD1 water sampler for a week; Flyght will be looking into low current draw at Pump #1, Cty KK.

4. **Select Geotechnical exploration proposal for sewer repair project –** Motion by Stoelb, second by DesJardins to accept bid from River Valley Testing Corporation for geotechnical subsurface exploration, the amount not to exceed \$3,788.00, by roll call vote President Ehmann – aye, Stoelb – aye, Rostollan -aye, Hoffmann – aye, DesJardins – aye, motion carried.
