Update from the Town Chairman

Is it just me or does spring seem to be a little more stubborn this year? Although I'm an avid xc skier I'm ready to hang up my skies and dust off my running shoes. And with spring comes another Town Newsletter to update you on what's going on in your community. But first, and rightfully so, I would like to take the opportunity to sincerely thank our Town staff, officials, and the many dedicated volunteers who do the hard work to make this a great place to live for our Town residents. I truly appreciate their commitment to serving our community.

Here's what's going on.

1. **Volunteer Opportunities** – Speaking of volunteers, we currently have an opening for a community member to serve on our Fire Advisory Committee. The committee serves as an advisory body to the Town Board on such fire department matters as budgets, by-laws, pay structure, education requirements and equipment needs, to name a few. The only requirement is that you have an interest in helping the fire department to be the best it can be to serve our community. Terms are 3 years and meetings are held on the third Wednesday of the month.

We also have an opening for a volunteer on the Parks & Forestry Commission. This commission not only serves as an advisory body to the Town Board, it is a true boots-on-the-ground group that oversees and maintains our Town parks and conservancies. The commission meets on the first Tuesday of each month. Stepping down from the Commission is Tom Kultgen, who has devoted hundreds of hours to this committee and was instrumental in the development of Schinker Creek Park and the more recent revitalization of Fireman's Park. I would like to personally thank Tom for all his service to the Town.

Wage and Salary Committee meets once every two years to evaluate the salaries of the Constables, Town Board Chair and Supervisors, if you would be like to be a member of this committee please contact the town office.

2. **Annexation** – There are two things I would like to convey about this contentious issue. First, here is a brief update on the lawsuit filed by the Town of Wilson against the City of Sheboygan challenging the legality of the Kohler Company petition to annex 546 acres of Town land into the City. Subsequent to the Sheboygan

Common Council's approval of the annexation in August of 2017, the Town of Wilson Board filed suit against the City in Sheboygan County Circuit Court seeking a summary judgment to overturn their action. In addition, the Town filed for a temporary injunction to halt any activity related to the annexation until a final decision was rendered on the lawsuit. An initial hearing was held on October 10, 2017 in front of Judge Daniel Borowski. Judge Borowski subsequently ruled on November 3 against the Town's request for a temporary injunction and set a hearing on the lawsuit for February 16, 2018. After hearing oral arguments on February 16, Judge Borowski eventually denied both parties' motions and sent the case to a bench (not jury) trial scheduled for May 9-11. At that point the losing party will have the option to appeal the Judge's decision to the state appellate court.

And second, I would like you to be aware that the Town Board recently established an ad hoc committee to address potential further annexation related issues facing the Town. The broader potential objectives of the committee are to open a public dialogue on annexation, better understand the implications to the Town of Wilson, identify potential remedies, inform the public, and make recommendations to the Town Board. We are in the process of scheduling the committee's first meeting, so if you are interested in attending make sure you monitor the Town's website for that announcement.

3. **20-Year Comprehensive Plan** – In May of 2017 the Long-Range Planning Ad Hoc Committee completed a mandatory 10-year review of the Town's 20-year comprehensive plan. In its final report, which was subsequently approved by the Town Board, the committee identified several action items to be completed over the remaining 10 years of the plan. Now the committee is ready to reconvene to begin prioritizing and completing some of those recommendations. The committee will be meeting on the third Thursday of the month beginning on April 19 at 6:30 in the Town office. The public is welcome to attend and participate in these meetings and to also assist in the implementation of these initiatives.
4. **Change on the Town Board** – Many of you may know that Supervisor Dan Rostollan has made the difficult decision to not run for re-election this year after dedicating over 6 years of service to the Town Board. Dan has been a tireless advocate for our Town residents over that time and I would like to personally thank him for the guidance and expertise he provided me over the past 3 years which has been invaluable in helping me learn and carry out my role as Town Chairman. I wish him all the best in his future endeavors.

Replacing Dan will be Matt Fore, who is running unopposed in the spring election. Matt currently serves as a volunteer on the Town of Wilson Fire Department and Fire Advisory Committee. I would like to welcome Matt to the team in advance and I very much look forward to working with him in the coming years.
5. **New City Business Park** – The Town's Sanitary District No. 1 Commission is currently working with City of Sheboygan officials to accommodate the City's sewer needs for their new business center expansion project along the I-43 corridor south of Weeden Creek Road. The City will be expanding the size of a section of Town owned sewer pipe along South Business Drive from Stahl Road to Weeden Creek Drive from its current 10-inch diameter to 16 inches using a method called pipe bursting. Construction is slated to occur sometime in 2018 with a minimal disruption in service.
6. **CTH OK/South Business Drive Road Project** – The County is expected to complete its S. Business Drive road project this year by installing a second and final layer of asphalt as soon as the weather cooperates.
7. **Other County Road Projects** – The County recently published their 5-year road paving and reconstruction plan. Here are some of their projects located in the Town of Wilson.

- 2018 – CTH KK (Moenning Road) from CTH V to Stahl Road
- 2020 – CTH V (12th St.) from the State Park to the City
 - CTH A from CTH V to CTH EE (Weeden Creek Rd.)
 - CTH EE (Weeden Creek Rd.) from CTH OK to CTH A (major redesign and reconstruction)
- 2021 – CTH KK (Old Park Rd.) from Middle Rad to Sauk Trail
- 2022 – CTH EE (Weeden Creek Rd.) from CTH OK to 12th St. (major redesign and reconstruction)
- 2023 – CTH V from STH 32 to I-43

8. **New Contract with County Sheriff’s Dept.** – The Town Board entered into an agreement with the Sheboygan County Sheriff’s Department beginning April 1 to purchase 20 hours of their services a month, including some additional general patrol duties and assisting with enforcement of our Town ordinances and with special assignments and events. This agreement is intended to augment the great work already performed by our elected Town Constables and to improve public safety order in the Town.
9. **Stormwater Management and Erosion Control** – The Town Board took action on January 3 to repeal its stormwater management and erosion control ordinances and transfer the permitting and enforcement of these functions to the County. The Town and County have similar ordinances, so this action will essentially eliminate what we considered to be a duplicate of efforts that will improve operating efficiencies for the Town.
10. **Black River Museum** - I would like to make you aware of the newly created Black River Museum, located at 5512 Evergreen Drive next to the fire station. The museum celebrates the history and natural resources of this unique region along Lake Michigan’s shore. Adults and kids of all ages will find the exhibits both interesting and educational. The museum is open on Sunday afternoons from 1-3 p.m. beginning Memorial Day weekend through the annual Fall Fry celebration in October.

1. **HINT:** Dog License, Property Tax directions and the Town's Annual Audited Financial Report are under the "Info On" tab on the Town's new website www.townwilson.com. The Financial Report is on the Tax page.
2. **HINT:** Do you ever wonder if your property tax payment was posted to your account? Now, You can check the Sheboygan County's new portal [<https://treasurer.sheboygancounty.com/GCSWebPortal/Search.aspx>] to verify receipt of your payment. This site is updated nightly! There is no need to call the office.
3. **Annual Dog Licenses:** Drop off or send a copy of the current rabies certificate and fee to the Treasurer - after March late fees are assessed. Currently, the fees are \$7/ea. for spayed/neutered and \$14/ea. for non. I will process these licenses every Thursday afternoon and send you your dog's tag, rabies certificate & license. The drop box is located left of the glass entrance doors. By the way, if you keep your pet for hobby breeding, you must declare so per Town ordinance Chapter 62.07.

Park and Forestry Commission Report

March, 2018

Winter weather caused a delay in the completion of the upgrade to Gruber Memorial Fireman's Park and Jung Bell Tower Park; we were unable to finish the public rest room addition to the west side of the firehouse. The sink, toilet, and water station could not be installed due to the cold weather. We hope the month of March will be kind enough to allow those installations as well as completing the door security locking system. Concrete must be poured at the entrance and at the water station on the south side of the rest room. When complete, the rest room will be handicap-accessible and the security system will be programmed to automatically "open" at 6:00 AM and "close" at 10:00 PM, following the park hours as posted. Don't worry – you will be able to lock the door when you use the rest room, but you cannot get locked in by accident!

We have not yet received notification of approval for our request for a grant from the "Feed a Bee Pollinator" program. We have requested a \$5,000.00 grant to begin to remove Japanese barberry plants from the Henry Mueller Family Conservancy and replace that invasive species with flowers and shrubs to attract pollinators, such as bees and butterflies. We would like to include native, non-invasive plants to the mix.

The Emerald Ash Borer Mitigation Program enabled us to plant 44 trees in Schinker Creek Park. The trees were planted by neighborhood volunteers and the Park and Forestry Commissioners last June; we passed our WisDNR compliance inspection last fall and received our grant funds. In addition, Gerry Bertsch, Former P&FC Commissioner now on the Town's Plan Commission, matched a grant from the American Transmission Company to enable us to plant 4 oak trees in Schinker Creek Park.

The Commission will review and discuss the opportunities available under the 2018 Sheboygan County Stewardship Fund Grant. The Stewardship Grant program enabled the Town of Wilson to buy and equip Schinker Creek Park and fund the upgrade to Fireman's and Bell Tower Parks. If any community members have suggestions for park and recreation projects, please contact a P&FC Commissioner or stop in the Town Office to share your suggestion!

Keep Wipes out of the Pipes

Did you know that flushing wipes down the toilet is bad for the sewers? While many items state “do not flush” in smaller print, even “disposable wipes” and “flushable wipes” have been proven to cause problems in municipality sewer systems. When these wipes don’t break down in the sewers it can lead to costly cleanups and may result in basement backups. The environmental consequences of these clogs can be costly to the Sanitary District as well as to you and your neighbors.

Common offenders include: feminine sanitary products, prophylactics, cleansing cloths, pre-moistened towelettes, baby wipes, diapers, rags, disinfecting wipes, Swiffer mop refills, toss-in toilet bowl wands, paper towels, and shop towels/rags. Just because a product is labeled “disposable” or “flushable” doesn’t mean it will dissolve or breakdown in the sewers. If it doesn’t dissolve as quickly as toilet paper, please place your wipes in the trash can. All wipes and disposable cleaning products belong in the trash, not the toilet.

TOWN OF WILSON FIRE DEPARTMENT STATUS UPDATE

The fire department personnel worked very hard this past year to complete all our 2017 goals.

1. Administratively we created a goal of updating and documenting the new firefighter onboarding process. This was completed with some added tasks of cleaning out and updating operational gear and uniforms as well.
2. We set some training goals outside of our Tuesday night drills. First goal, to complete driver training for all firefighters that will drive the apparatus. The total number of firefighters that completed the entry driving class at LTC was 9. Second; complete the flashover training at Milwaukee Area Technical College. We had 14 firefighters attend the flashover training in Milwaukee over two weekends.
3. The goal for recruitment was two new firefighters for the year of 2017. We exceeded our goal by recruiting 4 new firefighters and 1 explorer moved into the ranks as firefighter. We also recruited 3 new explorers this past year.
4. Our final goal was to complete the United States Lifesaving Association (USLA) Aquatic Rescue Response Team (ARRT) certification process. This was completed in October.

The dedication that the team displayed this past year is greatly appreciated, thanks to all the members for a successful year.

FIRE SAFETY

Spring time is upon us and it is important that everyone understands that outside burning, other than cooking fires and small campfires require burn permits. Please contact the fire department or the town hall if you have any questions regarding burn permits. All contact information is on the Town of Wilson website at: <http://townwilson.com>. For a complete copy of the Fire Prevention and Protection Ordinance visit the Town of Wilson websites ordinance page located at: <http://townwilson.com/town-of-wilson-ordinances/>.

Please check your Smoke detector and CO detector batteries and expiration dates. It is important to maintain these units and keep them in working order, so they will function properly. The CO detectors can have expiration dates on them (usually they are good for 5-7 years.) When your detector “chirps” and isn’t alarming it may need to be replaced. Check the dates on your detectors and replace them when they expire.

Your Town of Wilson First Responders had a busy 2017!

We successfully completed the required refresher course. This is done every 2 years to ensure we are up to date on our skills and trained on what's new or changed since our last refresher.

We had a patch created and sewn for our unit. One of our responder's son drew up the design that we were able to have transformed into a patch.



We responded to 3 fire calls and 122 medical calls and treated 125 patients. In addition to those calls we also volunteered at Campus Life's YAK attack and the Tough Mudder in Elkhart Lake. We walked in the 4th of July Parade handing out a little over 5,000 pencils and during the Community Open House in October, we proudly had our Incident Response trailer on display.

14. **Lead-acid batteries** (Car, Truck, Motorcycle, Lawn Mower batteries)

MANDATORY RECYCLING

Recycling is mandatory in the State of Wisconsin and statutes have established responsibilities for local governments relating to recycling. The Town of Wilson is required to maintain an effective recycling program for solid waste management, which includes educating its residents about the recycling law. On-going education that reminds residents about local recycling programs is essential for maintaining high recycling rates in our community.

SINGLE STREAM RECYCLING: Single stream recycling simply means that you can now place all of your recyclable items in a **BLUE** bag. Everything goes into a blue bag: #1 to #7 plastics, aluminum, glass, newspaper, chip board, magazines, catalogs, shredded paper, etc. This is a convenience option, it is not mandatory. There will be one recyclable item that will not be placed in a blue bag and that is **CARDBOARD**. It's been recommended to separate cardboard for placement into its own dumpster. The Town shall restrict recyclable items from being placed in our garbage containers. This is consistent with **ORDINANCE 65.02**. Please visit our website to view the entire ordinance (<http://townwilson.com/>)

RECYCLING IS A WISCONSIN STATE LAW, we will not accept garbage bags that contain recyclables inside. Town residents that have not separated their recyclables will be directed to return home and resort your items if your clear bag contains recyclable items. There is no landfill disposal costs attributed to recyclables so this will help to reduce the cost for all of us in disposal fees. The town of Wilson requires residents to place recyclables into a **BLUE BAG** and garbage items into a **CLEAR BAG, NO EXCEPTIONS**. Recycling Center Staff must be able to clearly see through your bag to insure proper disposal of solid waste. This is Wisconsin State Law and simply the right thing to do for our environment.

What is Recyclable?

ACCEPTABLE CONTAINER PRODUCTS

Aluminum Cans, Trays, and Foil
