

**SANITARY DISTRICT NO. 1 COMMISSIONERS MEETING  
TOWN OF WILSON, SHEBOYGAN COUNTY, WISCONSIN  
APPROVED MINUTES OF MAY 07, 2018**

**CALL TO ORDER & DECLARATION OF OPEN MEETING:** President Ehmann called the Sanitary District No.1 Commissioners Meeting to order at 5:30 p.m. Posting in accordance with open meeting law was confirmed by affidavit of posting and the meeting was declared an open meeting.

**PRESENT:** President John Ehmann, Commissioners Tom Stoelb, Matthew Fore, and Nancy DesJardins, Brian Hoffmann.. Also in attendance: Secretary Georgene Lubach and Clerical Assistant Mandy Tran.

**NEW BUSINESS / APPOINTMENTS:**

1. **Approval of draft minutes;**
  - a. **April 16, 2018, Commissioner Meeting Minutes - Motion by Stoelb, second by DesJardins to approve the April 16, 2018 draft minutes, all members voted aye, Hoffmann and Fore abstained, motion carried.**
2. **Maintenance related issues as presented by Tom Sanville and/or Otis Kiehl – No report.**
3. **Reports:**
  - a. **Clerical Assistant** – Tran reported status of Indian Mound Sewer Improvement Project. Submits notice of resignation and thanks Town Commissioners and Staff.
  - b. **Treasurer** - Sanitary District No. 1 balance sheet, cash balances and activity in written report.
  - c. **Secretary** – Clerk reported on telephone utility matters.
  - d. **Commissioners** – Stoelb reported Indian Mound Road Sewer Improvement Project completed today.
4. **Sanitary District No. 1 Disbursements – Motion by DesJardins, second by Hoffmann to approve disbursements for 5/7/18, check numbers 2489-2496 for \$27,696.45, all members voted aye, motion carried.**

During the closed session, the Commission will discuss the City of Sheboygan's CTH OK sewer project. Roll call vote required. The Commissioners reserve the right to reconvene to open session to take action on the subject of the closed session.
