### **CHAIRMAN CHAT - An Update from the Chairman**

Hi neighbors. Well, the weather continues to be the main story as the rains keep coming, raising water levels and taxing sump pumps everywhere. We are doing what we can to assist town residents who are dealing with water related issues. To report any threatening or unsafe conditions please call the town office at **208-2390** or the Sheriff's Department at **459-3111**.

As customary I would like to begin by saluting the many talented volunteers who give countless hours of their valuable time to serve the town. They are firefighters, first responders, constables and election workers. They serve on our Plan Commission and Parks & Forestry Commission. They are members of our Long-Range Planning Committee, Fire Advisory Committee, and Wage & Salaries Committee. They serve on our Board of Appeals and Sex Offender Resident Board. And still others make important contributions behind the scenes. If you run across one of them, please thank them for their service.

***Here's a brief update on what's going on. Fair warning, it's heavy on the topic of roads.***

**Annexation Lawsuit Update** – Most of you are aware that the Town of Wilson board filed suit against the City of Sheboygan in 2017 challenging the legality of Kohler Company's petition to annex 546 acres of Town land into the City. The Sheboygan County Circuit Court ruled against the Town of Wilson in November 2018 and the Town Board immediately filed an appeal to the Wisconsin Court of Appeals while simultaneously petitioning to bypass directly to the State Supreme Court. The Supreme Court accepted the case and the hearing took place on Sept 19th in Madison. We are awaiting the Supreme Court's ruling, as are many other townships throughout the state.

**Kohler Golf Course** – As previously reported, in March 2019, in response to a lawsuit filed by a local citizen group, a Wisconsin Administrative Law Judge revoked the wetland fill permit for the proposed golf course project in the Town of Wilson. The ALJ cited that the standards for issuing the permit back in April 2017 had not been met and that the DNR lacked sufficient information to grant the permit. Kohler is currently in the process of appealing the ALJ's decision in the Sheboygan County Circuit Court. Briefs are due from the DNR, Friends of the Black River Forest, and Kohler by December 23rd. The circuit court judge will make a decision sometime after that date.

**ATVs on Town Roads** – There have been reports of people driving ATVs on town roads. Although Wis. Stat. s. 23.33 allows ATVs and UTVs to operate on state highways in certain cases, some type of local government ordinance is required for that to occur. There are no instances of State, County or Town ordinances that allow for ATVs or UTVs to operate on any roads in the Town of Wilson, so please keep those vehicles off the roads. To report any incidents please call the Sheriff's Dept.

**2019/2020 Road Improvements** – The 2019 Town budget includes \$45,000 for road maintenance and \$102,000 for road construction. The following projects were completed in 2019:

- Edgewater Road and Driftwood Lane asphalt overlay (\$42,720)
- Indian Mound Road and Evergreen Drive patching and chip seal (\$77,383)
- Ditching, center lining, crack filling, culvert, shoulder work and other road projects (\$31,864)

A preview of priority road projects for the next two years is outlined below. Those projects selected for 2020 will be sorted out through the budget process over the coming weeks. The board will approve the preliminary budget at our regularly scheduled board meeting on November 4<sup>th</sup>. The Town's annual budget hearing is scheduled for November 21<sup>st</sup>, where public input is permitted and where the board will approve the final budget. Slated for discussion are:

- Garden Grove Drive & Woodside Lane - betterment and paving
- Juniper Drive - pulverize and pave
- Ourtown Rd - chip seal treatment
- Terry Andrae Terrace, Terry Andrae Avenue, Terry Court - chip seal treatment
- Timberlake Road - pulverize and pave, improve drainage
- West Evergreen Drive - chip seal treatment

**Weeden Creek Road** - Planning is underway by the County for a complete reconstruction of Weeden Creek Road between County Hwy A and 12<sup>th</sup> Street. Preliminary plans call for a substantial widening of the road, the addition of bike lanes and a sidewalk. Sewer replacement along the road corridor will likely begin in 2023, and the road reconstruction itself will take place in 2024, costing an estimated \$3.5 million.

**The Dollars and Cents of Maintaining our Town Roads** – The road work completed on Indian Mound Road and Evergreen Drive in recent weeks certainly raised a few eyebrows and some questions from town residents. It was a lesson learned for the Town Board that we can do a better job of communicating projects in advance. OK, so let's talk roads.

The Town Board is responsible for maintaining 39.6 miles of town roads. This is a tall task because in recent years the State has not taken the steps to adequately fund road improvements at the local levels. In fact, the Wisconsin Taxpayers Alliance graded Wisconsin roads among the worst in the nation, rating them a "D." And the American Society of Civil Engineers rated Wisconsin roads the 3<sup>rd</sup> worst in the nation.

The Town of Wilson receives approximately \$95,000 annually in general transportation aid from the State. And thanks to the bold action of our County Board, we now receive an additional \$65,000 - \$70,000 in road funds from the County's new ½ percent sales tax program. The additional road maintenance costs must be funded from our town tax levy.

To address expenses let's talk about the rapidly rising costs of road maintenance. The lifespan of an asphalt road overlay is approximately 15 years, which means that in order to maintain our roads to adequate standards, 2.6 miles of road should be paved each year. The method and cost of paving each road differs depending in its condition. For example, it costs approximately \$120,000 per road mile for a 2 ½ inch overlay and \$250,000 for a 4 inch overlay. And one mile of completely reconstructed road costs up to \$1,200,000.

In addition to repairing and maintaining our roads, we spend on average another \$100,000 annually for snowplowing and salting. We also have 5 bridges and several culverts to maintain in our town. For example, we rehabilitated the Wilson/Lima Road Bridge in 2016, at total cost of \$220,628 and a net cost to the Town of over \$110,000. So like any other municipality, the Town must look for ways to extend the lives of our roads.

Now back to the Indian Mound Road and Evergreen Drive road project. The treatment we chose is called chip seal.



It is a preventative maintenance treatment that seals cracks, creates a new driving surface, and extends the life of the pavement. It is one of the most common and economical treatments for paved roads, costing a fraction of a complete asphalt overlay. The process starts with spraying a thin layer of liquid asphalt on the road surface. Next small rocks, or chips, are placed on top. The chips are then compacted into the liquid asphalt and the excess are swept away. Traffic helps to further embed the chips into the road. In this instance, because these roads are located in a more urban setting, we performed two additional sweepings. We know this process can be a short-term nuisance, especially in residential areas, but it saves considerable taxpayer dollars and helps to extend the life of our roads.

Lastly, how do we prioritize our road projects? Each year the Town Board and our maintenance supervisor, Rick Meyer, take a tour of our town roads. We evaluate each road from 1 (failed) to 10 (excellent) in accordance with the State of Wisconsin's PACER (Pavement Surface Evaluation Rating) system, which also recommends certain treatments for each rating category. We consider these ratings along with traffic volumes, safety, public input and available funds in order to update our 5-year road maintenance plan. Our goal is to place more information on our website by year-end related to our road ratings and maintenance plans, and to keep that information updated. ## PARK AND FORESTRY COMMISSION

### GOODBYE BARBERRY

The Park & Forestry Commission was awarded a \$3,427 Stewardship Grant by the Sheboygan County Planning & Conservation Dept. to be applied to the cost of eliminating the Japanese barberry in the Henry Mueller Family Conservancy, located between the east end of Panther Ave and the Black River. The invasive plant has taken over approximately 75% of the land, making it impossible to walk through the Conservancy. The grant will cover approximately 1/3 of the cost to kill the barberry, mulch the dead plants, and plant native plant species to restore the Mueller Conservancy to the conditions of 20 years ago. The first spraying has been completed and mulching will take place after the first frost. Subsequent spraying will be done next summer.

# RECYCLING AND GARBAGE TRANSFER STATION

## NO TAG – NO BAGS

*(or branches, or yard waste, etc.)*

Since 2016, The Town of Wilson has used a residency identification tag system to ensure that our recycling center is only accessed by town residents.

***This method saves us all money.***

Town Residents are required to hang their I.D. tag from their vehicle's rear-view mirror enabling recycling center staff to easily identify residents. If you forgot your tag, you will not be allowed to use the facility. There is an exit point before the recycling center gate that you can use to leave and retrieve your tag. Town employees have been directed to strictly enforce these rules.

## ONE FOR FREE

*The rest a small fee*

I.D. tags are available at the recycling center during regular hours. Documentation of residency is required (*drivers license, utility bill, etc.*) prior to receiving a tag. If you lose your tag or your tag breaks you can be issued a replacement. Replacement for a lost tag is \$10 and a broken tag will be replaced for \$1. Present your broken tag to maintenance staff. Second tags for households with two vehicles are also available for \$10.

## HANG YOUR TAG

*It is your permit, no exceptions*

If you would like to use the recycling center and need a residency identification tag, the Town issues one permit per Town of Wilson address at no cost.

## THE RECYCLE ROUNDUP

**NEW RULES - NO BAGS REQUIRED** Recycling is up! This is great news. But it isn't enough to just toss it in a blue bag. In fact, we don't want you to! **We are rolling out a new initiative to save us all money.** Effective immediately, recycled items will be emptied out of blue bags and put into the dumpster loose. Paper bags like grocery bags filled with recycling can be used, or use a bin that can be emptied at the recycling center. Plastic bags clog up the process down the line from us and we've been instructed to discontinue using them.

Additionally, Over 25% of recycling is contaminated according to the National Waste and Recycling Association.

***If we don't do it RIGHT, it increases costs, and defrays our efforts.***

When contaminated things are put in with recycling, they require sorting at a recycling facility. *This adds to costs and increases fees.*

Please RINSE your recyclables, it goes farther than you can imagine in the post-consumer process. Pizza boxes with cheese or grease are contaminated, jars and cans with food still in them are contaminated.

When recycling, remember the 4 R's!

## HOME SAFETY

Fall is upon us and as we move into the cooler weather, please remember these few home safety tips.

**Carbon Monoxide & Smoke Detectors** - Sunday, November 3<sup>rd</sup> is the end of daylight savings. This is a great time to check your smoke detectors and your Carbon Monoxide detectors and maintain them as needed. With many smoke detectors now hard wired in homes the batteries last much longer, but still require changes. Carbon Monoxide detectors also require maintenance, please check for expiration dates on the sensor packs or detectors as well.

**Space Heaters** - When using space heaters this winter: First and foremost, **never leave them unattended.** Space heaters that are unattended are very dangerous and can cause fires quickly if the unit gets tipped over or faults out and no one catches it immediately. Make sure that when using space heaters there is no clutter around the unit.

*Updated units are much safer than older units and if you choose to update a unit make certain it is UL Listed and has "Tip Over Protection."*

## APPARATUS UPDATE

The Town of Wilson Fire Department recently purchased a 2007 Pierce 1500/1000 Rescue Pumper for \$195,000 to replace older units. The firefighters put in a lot of extra time and effort updating the Rescue Pumper saving many dollars to the taxpayers. The total project cost roughly \$210,000 compared to a new Engine costing \$525,000. The Town of Wilson also was able to sell their old engine and squad vehicle. This move was done to support the long-range plan of the fire department, reducing the fleet to four trucks. This was a large undertaking by the firefighters and what they did for the town taxpayers is very commendable, thank you all for doing this outstanding work!



Did you know there's such a thing as a fatberg? Not an iceberg...a FATberg. According to Wiki; "A fatberg is a congealed mass in a sewer system formed by the combination of non-biodegradable solid matter, such as flushable wipes, and congealed grease or cooking fat." ## TAX UPDATE

Property tax time is just around the corner. Bills will be mailed by mid-December, at least the first half is due by Jan. 31<sup>st</sup>.

Here are several options for making first half and full payments:

- Payments can be made at the Town Office during regular office hours and the drop box to the left of the main door after hours prior to February 1st.
- Alternatively, payments can be made at Wisconsin Bank and Trust with a teller from 9 a.m. to 4 p.m., their locked indoor lobby box (payments processed next business day) during lobby hours.
- Online at [www.townwilson.com](http://www.townwilson.com) Online payments by e-check are \$1.50, and a

- Mailing your payment to the town office is always an excellent option.

## DOG LICENSES

Dogs older than 5 months that call the Town of Wilson home must have a license. Once a dog turns 5 months old a license is required. Recently acquired dogs older than 5 months need to be licensed within 30 days. 2020 licenses will be available in early December, 2019. Licenses are valid from January 1st to December 31st.

## LICENSE FEES

Spayed or neutered dogs license fees are \$7, while intact dogs are \$14. Puppies get a break! If they turn 5 months of age after July 1st, the license fee is 50% of the normal charge. A copy of a current rabies vaccination is required to license a dog.

**\$25 late fee after March 31st for dogs not properly licensed.**

# NEW RECYCLING RULES - NO BLUE BAGS

---

*Keep this sheet for future reference Dated: April 2020*

1. UNBAGGED OR PAPER BAGGED co-mingled recyclables/glass, plastic (numbers 1-7), aluminum, steel containers (containers must be rinsed and caps removed)
2. Branches or brush
3. Clear BAGGED household garbage. Garbage must be bagged – no loose garbage will be received
4. Newspapers – not in plastic bags
5. Magazines – not in plastic bags
6. Chipboard – not in plastic bags
7. FLATTENED cardboard
8. Grass clippings and leaves – UNBAGGED YARD WASTE
9. Small amounts of wood and lumber – clean, untreated wood only, that is able to be chipped
10. Ranges, water heaters and other METAL
11. Tires (\$3.00 per car tire / \$6.00 per truck tire / \$10.00 per tractor tire will be charged)
12. Waste or drain oil in no larger than 2-gallon containers
13. Empty or dried latex paint cans
14. Lead-acid batteries (Car, Truck, Motorcycle, Lawn Mower batteries)

**Separated aluminum cans are still accepted at the transfer station for donation to the town. We use the revenue to reduce costs!**

Recycling is a State of Wisconsin Law. We will not accept garbage that contains recyclables inside. Town residents that have not separated their recycling will be directed to return home to resort their items. The Town of Wilson's **NEW RULES** require recycling to be either recycled in paper garbage bags, or placed directly into the dumpster loose. A bin can be used for convenience and emptied directly into the dumpster.
