ORDINANCE AMENDING CHAPTER 6 OF THE
TOWN OF WILSON CODE OF ORDINANCES

The Town Board of the Town of Wilson, with quorum present and upon proper notice, hereby ordains the following amendments to Chapter 6 of the Town of Wilson Code of Ordinances:

Section 6.01 is hereby amended to read:

The Town Board has the authority pursuant to Wis. Stat. § 60.22(4) to specify jurisdiction and duties of the Town of Wilson Constable(s).

Section 6.03 is hereby amended to read:

The Town of Wilson Constable(s) shall have no jurisdiction.

Section 6.04 is hereby amended to read:

The Town of Wilson Constable(s) shall have no duties.

Section 6.05 is hereby amended to read:

This ordinance does not preclude the Town Board from adopting any other ordinance or entering into any other agreement designed to address peace and order or to enforce laws and ordinances in the Town. Nor shall the jurisdiction and duties of the Town Constable(s) as stated herein preclude the Town Board from proceeding under any ordinance or law or by any other enforcement method to enforce any ordinance, regulation, or order.

Section 6.06 is hereby repealed.

All other provisions of Chapter 6 of the Town of Wilson Code of Ordinance shall remain in full force and effect.

The Town Clerk and Town Attorney are hereby authorized and directed to take all action necessary to implement this Ordinance.

This Ordinance shall be posted or published in accordance with Wis. Stat. § 60.80.

Effective date: This ordinance shall become effective upon adoption and publication as required by law.
