

CHAPTER 3

FIRE PREVENTION AND PROTECTION

Whereas, the Town of Wilson is concerned about residents burning refuse within Town limits, based on concerns about safety and the environment;

3.01 Burning Refuse Prohibited.

It shall be unlawful for any person to burn out of doors refuse within residential zoned districts in the Town of Wilson.

3.02 Open Burning Prohibited.

It shall be unlawful for any person to kindle, start, or maintain a fire in the open air within the Town of Wilson, except as provided in Section 3.03. All other forms of open burning, other than those listed in Section 3.03, shall be prohibited without authorization from the Fire Chief of the Town.

3.03 Exceptions to Open Burning Prohibition.

Open burning is permissible under the following conditions:

- a. Practice fires set by any organized fire department for practice or instruction of firefighters, or testing firefighting equipment;
- b. Fires set by fire or law enforcement personnel for the purpose of burning explosives or dangerous material for which there is no other safe means of disposal;
- c. Fires set for outdoor cooking as long as the wood or other non-explosive fuel is being burned for the purpose of cooking is kept under constant supervision is contained in a substantial burner and is not closer than ten (10) feet to any building;
- d. Recreational bonfires or campfires as long as the fuel for bonfires consists of wood only is not ignited with flammable or combustible liquids, is not closer than twenty (20) feet to any building or structure or pile of lumber/wood and is not more than twenty-four (24) inches above grade or the landscape; firepit diameter may not be larger than 42". Legal Non-Conforming Fire Pits. Any residential fire pit located in the Town of Wilson as of the 8/19/2018, which does not conform to the provisions of this ordinance, is eligible for Characterization as legal non-conforming fire pit and is permitted.
- e. Burn barrels may not be allowed unless the barrel is 30 gallons or smaller.
- f. Flame may not be higher than 24".
- g. Firepit is in an area clear of vegetation within a four- foot perimeter, has a mineral soil break and is not located underneath trees and/or other vegetation. Burning of brush or weeds on agricultural lands is allowed with a permit from the Town Fire Chief or his designee.
- h. No person shall burn any painted, stained or treated wood, wood products containing glues or resins, wet combustibles, rubbish, garbage, plastics, shingles, foam, furniture, wire, metal, electronics, vinyl products, rubber products or oil-based products, any material capable of generating black or noxious smoke or any building materials associated with construction, remodeling or demolition.
- i. No burning nor the by products of combustion resulting from burning shall be allowed to form a hazard or nuisance to neighboring citizens. At no time shall smoke or heat aided by such combustion be an annoyance or discomfort to the neighborhood or traveling public.
- j. No burning when fire danger is above HIGH Per Wisconsin Department of Natural Resources.

- k. Open fire and cooking fire shall be constantly attended by a competent person until such fire is extinguished. This person shall have a garden hose connected to the water supply or other fire extinguishing equipment readily available for use.
- l. The responsible party shall ensure that the fire has been completely extinguished at the conclusion of the burning activity.

3.04 Permit required.

Any person, firm or corporation may contact the Fire Chief, or an appointee of the Fire Chief, regarding approval for open burning other than under the circumstances specified in Section 3.04 of this Ordinance. Upon acquiring a valid burn permit, burning is permissible under the following conditions. The Fire Chief or appointee of the Fire

Chief may specify additional conditions and restrictions under which burning shall be conducted. Contact Town of Wilson office for Permit Application or Town of Wilson website.

- a. Permits must be procured 48 hours prior to a burn. Permitted burns are prohibited on Sunday and holidays (New Years Eve, New Years, Martin Luther King Day, Easter, Memorial Day, 4th of July, Labor Day, Thanksgiving, Christmas, Christmas Eve)
- b. The permit holder shall contact Sheboygan County 9-1-1 dispatch prior to the burn, notifying them of the location.
- c. Burning is not allowed when fire danger is above HIGH per WDNR.
- d. Burning is not allowed if wind speeds exceed 15 miles per hour.
- e. Burning shall only be conducted between one hour after sunrise and one hour before sunset.
- f. The person doing the burning MUST be in possession of this permit during the entire burn for immediate inspection by authorities.
- g. No fire shall form a hazard or nuisance to occupants of neighboring properties.
- h. It is forbidden to burn garbage, oil, rubber, tar paper, asphalt products or any non-wood or non-vegetation material.
- i. A garden hose or other fire extinguishing equipment adequate for the size of the fire MUST be available at the burn site.
- j. The fire must always be attended to until completely extinguished.
- k. Only one burn site per permit. If not on your property, signed permission from the property owner must be attached.

3.05 Enforcement.

The Fire Chief of the Town of Wilson Fire Department, and/or his designees, and/or the Town Board and/or Town's Enforcement Officers; the Sheboygan County Sheriff Office shall enforce the regulations of this chapter and all other laws relating to the prevention of fires, and the storage, sale, use and handling of combustibles and explosives.

3.06 Special Charges.

Whenever it is necessary for the Fire Department to contain, remove, or extinguish any fire on private property within the Town of Wilson, or to contain, remove, or dispose of any hazardous substance from private property within the Town, the Fire Department shall render to any party possessing, controlling, or causing the fire or discharge of hazardous substance a bill for the immediate payment of costs of the containment, removal, extinguishment, or disposal. For purposes of this subsection, the term "hazardous substance" means any substance which may pose a substantial present or potential hazard to human health, safety or the environment because of quantity; concentration; or physical, chemical or infectious characteristics.

3.07 Violations and Penalties.

Any person who violates, disobeys, neglects, omits, or refuses to comply with shall forfeit not less than One Hundred Dollars (\$100.00) nor more than One Thousand Dollars (\$1000.00) for each offense, together with the costs of prosecution, and in default of payment of such forfeiture and costs of prosecution shall be imprisoned in the Sheboygan County Jail until said forfeiture and costs are paid, but not to exceed thirty (30) days for each violation.

Effective date: This ordinance shall be in effect on the day after posting or publication as required by law.
