## **APPOINTMENTS / NEW & OLD BUSINESS:**

- 1. Approval of the draft minutes, May 15, 2023 Town Board meeting.** Motion by Hoffmann second by Stoelb to approve the May 1, 2023 Town of Wilson minutes, all members voted aye. Fore was absent. Motion carried.
- 2. Discussion on next steps in the evaluation process of the Town's deer population.** Chairman Ehmann told the residents that he and several other members of the board had received calls about the deer population. There was a meeting at the Advancement Hall with the DNR. Ehmann mentioned that no decision has been made by the board.  
Supervisor Stoelb said at this time the board has NO schedule at all for culling the deer in the Town. Where does the board go now was answered by the Town looking up ways to get a deer count in the Town. Study will be completed, and surveys will be sent out. A committee group will be formed to collect more data. If anyone would like to be on this committee, please call the clerk on 920-208-2390.
- 3. Discussion and possible approval for 2024 Fire Department pay increase.** Motion by Hoffmann and seconded by DesJardins for the pay increase for 2024. All members voted aye. Motion carried.

- 5. Discussion on possible amendments to the burn permit application and Chapter 3 Fire Prevention and Protection ordinance.** Discussion was held with the board members. The amendment will include that there will not be any burn barrels in the Town unless they are 30 gallons or smaller in residential zoning. The DNR website is: <https://apps.dnr.wi.gov/wisburn/> to check the current fire situation.  
Motion by Supervisor Stoelb seconded by Chairman Ehmann to amend the Chapter 2.03 (i) ordinance. The amendment will include that there will no burn barrels in the Town unless they are 30 gallon or smaller in residential zoning and per the WDNR website the fire danger the language will be higher than high.
