CHAPTER 31 TRANSFER STATION

Now, therefore, the Town Board of the Town of Wilson does hereby ordain Chapter 31 of the Code of General Ordinances of the Town of Wilson as follows:

- 31.01 Town Use Only. The use of the Town Transfer Station shall be limited to the disposal of refuse produced, accumulated and collected within the limits of the Town of Wilson, unless specific contracts have been made in writing, in advance by the Town Board. Identification Tag required to enter the Transfer Station. No parties are allowed to enter the facility without their Town issued identification tag hanging in clear view from the vehicles rear view mirror. One (1) Tag issued per household. No Exceptions. Parties entering and using the Transfer Station outside of posted hours will be issued a written warning from the Town Board for the first offense. Second violation will be a fine (see 31.12 Penalty) or loss of Transfer Station/Recycling Center privileges or both. Residential waste only is excepted, no business or commercial.
- <u>31.02 Non-Resident Dumping Prohibited.</u> No person not a resident of the Town of Wilson or the representative of a resident of the Town of Wilson shall use the Town Transfer Station for the purposes of dumping refuse. No person shall dispose of refuse produced outside of or from the outside of the Town of Wilson in the Town Transfer Station.
- <u>31.03 Hours of Use.</u> The Town Transfer Station shall be open for disposal operations as herein provided on such days and hours as the Town Board may hereinafter establish. The hours of permitted use shall be posted at the Transfer Station and thereupon be in full force and effect. Those hours being Tuesday's from 8:00 a.m. to 5:00 p.m. and Saturday's from 8:00 a.m. to 4:00 p.m. (excluding holidays)
- <u>31.04 Premises.</u> The Town Transfer Station premises referred to in this chapter shall be those premises operated by the Town for disposal of items, other than those set forth in subsection 31.06, located at 4430 Meyer Court, Sheboygan, Wisconsin, 53081,
- <u>31.05 Trespassing Prohibited.</u> No person without the consent of the Town of Wilson shall enter upon the Transfer Station premises during hours in which the Station is not in operation.
- **31.06 Disposal Limited.** The following items, along with any other items which are prohibited from disposal by regulations of the State of Wisconsin, shall not be accepted or disposed of in the Transfer Station: See transfer station attendant for disposal questions.
 - a. Freezers and refrigerators dehumidifiers, air conditioners;
 - b. Oil based Paint-related products, other than household paint;
 - c. Household hazardous waste, including lawn and garden pesticides, acids and bases, poisons, aerosols, old gasoline, gas cans, solvents, cleaners, thinners, and varnishes;
 - d. Demolition materials from building, remodeling, renovation and razing projects;
 - e. Refuse from commercial and/or industrial sites or operations;
 - f. Mattresses, box springs, lounge chairs, overstuffed furniture, carpeting, rugs and padding;
 - g. Animal carcasses:
 - h. Non-recyclable plastic or wood outdoor furniture;
 - i. Toilets, fiberglass or plastic sinks, tubs and washbasins, shower stalls;
 - j. Tree and Bush stumps
 - k. Large amounts of wood and/or lumber, concrete
 - 1. Dishwashers, Microwaves
 - m. E-Waste; all electronic items
 - n. Propane tanks

CHAPTER 31 TRANSFER STATION

31.07 Dumping on Public Streets. It shall be unlawful to dump or move onto any public street in the Town of Wilson any debris, refuse, or snow, at any time, or to place objects thereon, without specific permission from the Town Board. For purposes of this subsection, public street shall include any street, avenue, bridge, viaduct, underpass, overpass, and adjacent ditch in the Town, dedicated or devoted to public use.

<u>31.08 Dumping on Private Property</u>. In accordance with the laws of the State of Wisconsin Administrative Code, it is hereby declared to be unlawful to dump or store solid wastes upon private property unless said procedure is licensed by and done in accordance with the regulations of the Wisconsin Department of Natural Resources.

<u>31.09-Entrance to Dumpsters or Town Vehicles.</u> No parties are allowed to enter any dumpsters or Town of Wilson vehicles used for the Town Transfer Station operation.

<u>31.10-Removal of Items.</u> Removal of items from dumpsters or any vehicles used for the Town Transfer Station operation is not allowed.

31.11-Loitering. Loitering is not allowed at the Town Transfer Station.

<u>31.12-Mandatory Recycling</u>. As defined in Wis. Stat. 287.11, Ch. NR 544 of the Wisconsin Administrative Code and Chapter 65 Town of Wilson Ordinance.

31.13 Penalty. Any person, firm or corporation violating this ordinance shall forfeit and pay for each offense (and each day that such nuisance shall continue shall be deemed a separate offense) a penalty of not less than one hundred dollars (\$100.00), nor more than One Thousand dollars (\$1000.00)
