CHAPTER 2

SPEED LIMITS

<u>2.01 Purpose</u>. The purpose of this chapter is to establish the speed limit of roads under the Town's jurisdiction not already posted.

2.02 Authority. The ordinance codified in this chapter is adopted as authorized by Wis. stat. chp. 346 and 349 (1999-2000).

<u>2.03 Speed Limit.</u> All public roads in the Town of Wilson not listed below shall have a speed limit of 55 miles per hour unless otherwise posted.

<u>Speed limits 45 m.p.h.</u>-The maximum speed limit of forty-five (45) m.p.h. is hereby established on the following streets, roads, or highways pursuant to Sec 346.57 (4) (g) and/or (j), Wis. Stats:

- 1. Wilson Lima Road from CTH A to S. Frontage Rd.
- 2. Wilson Lima Road from S. Frontage Rd. to Pine Woods Ln.

<u>Speed Limits 35 m.p.h. - The maximum speed limit of thirty-five (35) m.p.h. is hereby established on the following streets, roads, or highways pursuant to Sec 346.57 (4) (g) and/or (j), Wis. Stats:</u>

- 1. Sauk Trail Rd. from CTH V to Middle Rd.
- 2. Old Park Rd. from CTH KK to Termini.

2.04 Adoption of State Traffic Laws Provision of State Law Adopted By Reference

Except as otherwise specifically provided in this code, the statutory provisions in Chapter 340 to 348, of the Wisconsin Statutes, describing and defining regulations with respect to vehicles and traffic, inclusive of any provisions therein relating to forfeitures to be imposed and exclusive of any regulations for which the statutory penalty is a term of imprisonment without a forfeiture, are hereby adopted and by reference made a part of this code as if fully set forth herein. Any future amendments, revisions or modifications of the statutes incorporated herein are intended to be made a part of this code in order to secure uniform statewide regulation of traffic on the highways, streets and alleys of the State of Wisconsin.

Effective Date. The herein Ordinance shall take effect upon enactment and publication.
